REPORT OF THE PROGRAM COMMITTEE

Ernest Kahn, Chair of the 1990 Program Committee, thanked the committee, the Philadelphia Host Committee, and the CJCS staff for their outstanding efforts in planning and bringing to fruition the 92nd Annual Meeting.

PRESENTATION OF AWARDS

—Louis Kraft Award. Irving Kessler, Chair of the CJCS Committee on the Kraft Award (for young professionals), presented the 19th annual award to Ruth Greenfield, Senior Planning Associate, Department of Budgets and Planning, United Jewish Federation of MetroWest, NJ, and Raiselle Eve Sheinkopf, Social Services Director, Sephardic Community Center, Brooklyn, NY.

—*Journal* "Article of the Year" Award. Joel Ollander, CJCS Executive Director, presented the annual Newman Trust Award for outstanding *Journal* articles to David M. Dunkelman, Executive Director, Rosa Coplon Home, Buffalo, NY for the article *The Jewish Nursing Home in the Year 2000*, and to Donald Feldstein, Associate Executive Vice President, Council of Jewish Federations, NY for his article *The Changing Client System in Jewish Philanthropy*.

Joel noted that the *Journal of Jewish Communal Service* is a singular CJCS contribution to the entire field of Jewish communal service—received and read by 3500

CJCS members and subscribed to by colleges, universities, libraries, and scholars throughout the world. It is the written record of our profession, preserving and advancing debates over philosophy and enhancing skills and practices through sharing of programs, he commented.

In recognition of the importance of the *Journal*, the Newman Trust Fund of San Francisco underwrites a *Journal* "Article of the Year" award, consisting of a plaque and a check. This year, Mr. Ollander stated, two outstanding professionals share the 1990 award: Donald Feldstein and David M. Dunkelman.

"Don has been a seminal thinker in the field for many years. His article points to new directions with respect to whom the Jewish community serves and from what sources future funding may come."

"David's article draws heavily on his experience as a highly successful administrator and practitioner. It articulates the directions in which we need be moving in order to prepare for the needs of our older population in the 21st century."

Judaism holds a special place of honor, care, and concern for our aged. Therefore, an integral part and key element in Jewish communal service is the North American Association of Jewish Homes and Housing for the Aging—NAJHHA.

Ronald I. Coun thanked the leadership and members of the Conference for their confidence by electing him president.

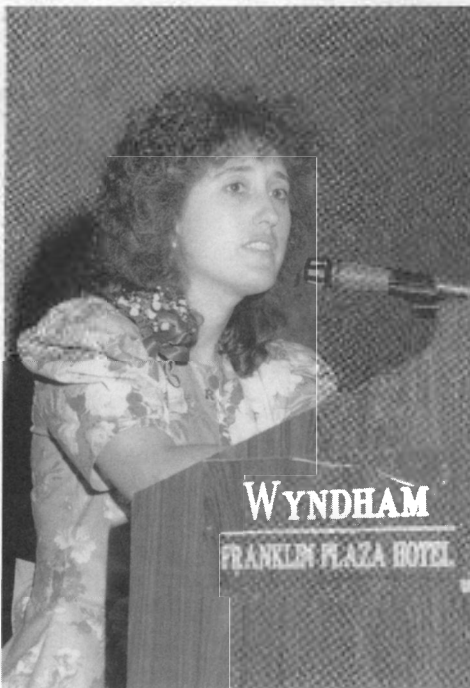
Ron pledged to work industriously over the next two years to move the Conference forward, so as to enhance the entire field of Jewish communal service.
